

DJ PERFORMANCE CONTRACT

This AGREEMENT (hereinafter referred to as the "Agreement") is made effective this _____ day of _____, 201__ by and between _____, located at _____ (hereinafter referred to as the "Purchaser") and Dj Shocase/Basic Image Entertainment, LLC (hereinafter referred to as the "DJ").

WITNESSETH:

In consideration of the respective covenants contained herein, the parties hereto, intending to legally bind hereby, agree as follows:

1. Performance. The entertainment to be provided by DJ is generally described as the manipulation of records on turntables *or equivalent (i.e. but not limited to CD player , IPOD, 8 track tape, cassette, AM/FM radio etc.)* (herein after referred to as the "Performance").

2. Venue. The place of performance is located at _____ (hereinafter referred to as the "Venue").

3. Date and Time of Performance. The date of the Performance shall be _____, 201__ and the time of the Performance shall be _____ until _____.

4. Agreement to Perform: DJ agrees to provide the Performance in accordance with the terms of this Agreement and any addendums or riders hereto.

5. DJ Fee: Purchaser agrees to pay DJ or his agent an aggregate of _____ DOLLARS (\$xxxxx.xx) for the Performance. A non refundable reservation fee of _____ is required to secure the services of Dj Shocase/Basic Image Entertainment, LLC. This amount shall be applied towards the DJ Fee. The DJ fee shall be paid in cash, money order, certified check or Pay Pal. **Condition Precedent: Remaining Payment must be made prior to Performance. *Services that exceed the agreed upon time duration for the Performance will be charged at the rate of \$50.00 per half hour**, payable the day of the Performance. _____ (Initial)

Deposits are only refundable if the DJ is unable to perform prior to the event and gives notice in writing _____ (Initial)

6. Excuse of Obligations. Purchaser and DJ shall be excused from their obligations hereunder in the event of proven sickness, accident, riot, strike, epidemic, act of God or any other legitimate condition or occurrence beyond their respective control.

7. Independent Contractor. DJ acknowledges that they shall perform their obligations hereunder as an independent contractor and not as an employee of Purchaser. DJ further acknowledge that they are not on Purchaser's payroll and social security or tax withholding rolls. DJ shall have sole control and direction in the conduct of the Performance.

8. Hotel and Transportation. Purchaser shall be responsible for the DJ's transportation and hotel accommodations. Purchaser shall also fax or email travel itineraries at least two weeks prior to event date. _____ (Initial)

9. Taxes. Purchaser agrees to prepare and file all tax information required of a person who hires the DJ and in return the DJ agrees that they have sole responsibility for the payment of any federal or state taxes arising from the monies paid by the Purchaser to the DJ for the Performance.

Additional Terms and Conditions:

It is here by further agreed; that the Purchaser shall be held liable for any injury or damage to the DJ or property of the DJ, while on the premises of said engagement, if damage is caused by Purchaser or guest, members of his organization, engagement invitees, employees, or any other party in attendance, whether invited or not. _____ (Initial)

Also, if the event is stopped by police or fight or an event not caused by DJ, payment must still be honored in full. _____ (Initial)
